Qualifying Conditions. The Qualifying Conditions must be met in order to serve on the Conference Executive.

Section 29 of the Constitution outlines "Qualifying Conditions" for serving on Conference Executive.

The **Qualifying Conditions** means that a person:

- 1) must be a member, in good standing, with a Conference Church;
- 2) must be of Christian faith and character;
- 3) must not be an employee of Conference, any Ministry Team, the Australian College of Ministries or any entity established by Conference or Conference Executive, whether incorporated or unincorporated, to further the objects and purposes of Conference;
- 4) must be endorsed as a candidate for election by two members of a Conference Church who hold senior leadership positions with that Conference Church;
- 5) must consent in writing to being a candidate for election to the relevant office;
- 6) must sign a statement that they will support the Objective of Conference;
- 7) must not be a person who is of unsound mind or a person whose estate is liable to be dealt with in any way under the law relating to mental health;
- 8) must be a person with a current "working with children check" and/or such other similar form of endorsement determined by Conference Executive;
- 9) must, as a condition of nomination, undertake that he or she must subscribe to [Governance Standard 5 of the Australian Charities and Not-for-Profits Commission](#); and

Please note nomination to be submitted and received no later than **5pm on Friday 2 October 2026**.

- 10) must undertake to sign and deliver to the Conference President from time to time a declaration that he or she is not disqualified under [Governance Standard 4 of the Australian Charities and Not-for-Profits Commissioner](#).

(Words and expressions defined in the Constitution of Churches of Christ in NSW which are used in this Nomination Form have, in this Nomination Form, the meaning of the words and expressions defined in that Constitution). Confirm my willingness to be nominated to serve on Conference Executive;
